MONTHLY **Need Flexibility?**

Our Monthly rate is a competitive and flexible rate for both short and long term stays. It's payable monthly and you can add a casual or permanent live-on-board agreement as you need it.

The monthly rate is intended to service both short term and long term customers who prefer recurring payments made monthly, providing flexibility for those who need it. You can pay as little as a month and then head off cruising without being locked into a longer term. Our monthly rate is the only rate that can be paid monthly.

QUARTERLY – **Staying awhile?**

With value in mind, we've designed our Quarterly rate to suit our medium term stays. It can be a recurring long term rate if you choose and you can add live-on-board agreement to suit. This rate is payable only in 3-monthly blocks. As you would expect, the longer the term – the cheaper the rate. This year, we've only indexed our Quarterly rate with the key change being that eligibility for the cheaper rent requires payments in 3 monthly blocks. Like previous years, our Quarterly rate is not available for payment on monthly intervals as it has in the past.

6 MONTHLY – **Long term savings!**

Our best value rate for long termers. Big savings the longer you stay and you can add a flexible live-on-board agreement to suit. 6 monthly agreements are only payable in 6-monthly blocks. In 2015, we introduced a long term 6-Monthly rate -in recognition of the long term commitment many renters have made to Breakwater Marina. This 6 Monthly puts forward genuine savings for our long termers and value against our competitors. As with the Quarterly, our 6 Month rates will only be available for recurring 6 month periods and not for shorter intervals.

There are 3 additional points to be made:

1. **Long Term Live On Boards and Concessional GST**

If you are living on board your boat for 28 days or more consecutively, you are entitled to a discounted rate of 5.5% GST which effectively reduces your cost of mooring and live on board fees. Claiming credits for days not on board does stop the discounted GST and therefore reverts your mooring and live-on-board fees back to the higher 10% GST. We recommend you check your days-off credits are worth claiming.

2. **Air Conditioner Levy for Excessive Use**

The Marina mooring rates and live-on-board fees account for normal residential use and consumption of all services and utilities. It's common knowledge the cost of electricity has hiked markedly over the last few years and the Marina has observed remarkable increases in that cost, but also consumption.

This year, we're enforcing an all-year-round user pays. Where vessels are using air conditioners in excess of what can be regarded as normal residential use, then it is expected the vessel owner pays for the additional consumption.

3. **Living On Board**

Additional costs are outlined if you choose to live aboard your vessel – this "service fee" covers services and utilities that are attributed to the live-in agreements, like rubbish collection, waste facilities and cleaning the amenities.
